#### 3. Matters Arising.

3.1 Outdoor Range. The association is still negotiating with the West Edinburgh Pistol Club (WEPC) regarding a joint development of the range site at Eddleston. The committee believe that the site represents the best opportunity for an outdoor range and are now looking at ways to raise the capital to improve the site. Inquiries are being made into the possibility of a Scottish Sports Council lottery grant and any fund raising ideas from members of the association would be appreciated.

The WEPC are continuing with improvements to the site, with top soil on order, anyone willing to volunteer their help should contact a member of the committee.

The association is looking for a volunteer to act as the chairperson of the range development sub-committee.

3.2 Captain's Report 1997. Mr McDonald had raised a complaint at the 1997 AGM saying that credit was not being given to all shooters who had represented the county. Mr Buchanan read the letter of response he had received from Mrs McIntosh (former captain). In summary Mrs McIntosh suggested that clubs and individuals need to provide the association with full details of performance and achievement in events outside the county. Anything to report should be sent to the captain or the secretary, this would also allow its inclusion in the newsletter.

#### 4. Financial Statement.

Miss Bell presented the accounts in an un-audited form; she explained that this was due to the fact that a full set of bank statements had not been received following the death of Mr Bryson (the former treasurer).

Miss Bell raised several main points:

- 4.1 Competition entries were down: the association provides a variety of competitions clubs and individuals should support these as best they can.
- 4.2 Association clothing, the initial set up charge was highlighted and it was emphasised that this was a one of charge. There are still some items of clothing available.

- 4.3 Tent hire, because of the expense incurred hiring a tent at the Scottish meeting the association has decided only to have a Lothian's tent at Lauder. This decision has been made because there is a higher percentage of association members attending the Lauder meeting and making use of the facility.
- 4.4 Multiple accounts. The range development account has been merged with the main association account. This will improve the amount of interest received.

Miss Bell asked if there were any questions. There were none. Mr Buchanan reminded the AGM that the accounts were un-audited and asked for approval in their current state.

#### 5. Captain's Report.

NSRA Leagues. The captain read the county teams results (details available from the vicecaptain). The county league teams had not been as successful this year, partly due to their promotion to division one. He thanked everyone who had shot in the teams and gave a rallying call to all future team members. He went on to stress the need to raise the standard for each round by 5-10 points, that would be only 1/2 to 1 point per person.

The National meeting: attendance at Bisley by association members had been poor in the previous year and this had caused problems forming county teams. The captain emphasised the benefits of shooting in the open and hoped that more association members would attend next year. He added that results from Bisley should be published nearer the meeting, and suggested their inclusion in the newsletter.

Summer Competitions. Results from last year's summer competitions were read out (details available from the vice-captain). The Provincial Cities and Boroughs for the next year has already been shot. The captain thanked everyone who had taken shot in the teams.

The Captain closed his report by wishing Bill Gibbon a speedy recovery following his surgery. Mr Buchanun thanked the Captain.

#### 6. Election of Office Bearers

The Vice-President, Mr Buchanan, explained that Mr Thomson had agreed to stand for one final year, and added that Mr Thomson was doing sterling work with the outdoor range. Mr Buchanan nominated Mr Thomson for President; this was seconded by Mr C Drysdale. There being no other nominations, Mr Thomson was duly elected as President of the Association. Mr Coates nominated Mr Buchanan as vice chairman; this was seconded by Mr Ogle, there being no other nominations Mr Buchanan was elected.

The Vice-Chairman intimated that he would accept an en bloc nomination for the remaining committee posts. Mr Buchanan read a list of those currently standing, and asked for nominations from the floor.

There being no other nominations, the following were duly elected:

Mr Buchanan pointed out that at last years AGM the position of County vice-captain had not been filled; following the AGM Mr Jackson had been co-opted to the post. Mr Buchanan proposed Mr Jackson for the position; this was seconded by Mr Ogle. There being no other nominations Mr Jackson was elected vice-captain.

The retiring ordinary committee members this year were Mr Hermiston and Mr Broughton, both had indicated that they would be willing to stand again and were therefore re-elected. Mr Buchanan explained that the sad death of Mr Bryson had left a further ordinary committee member position needing to be filled. A nomination received from Mr T Brown was accepted. Mr Brown was elected to fill the two remaining years of Mr Bryson's term.

### 7. Any Other Business

- 7.1 Mr Drysdale reported that Musselburgh Rifle Club was offering a quantity of material that could be used to develop the outdoor range at Eddleston. Railway sleepers and wood from the old firing point at Musselburgh would have to be moved by members of the association but it was being offered as a donation. As yet the National Trust have imposed no date by which the site must be cleared.
- 7.2 Mr Wilkie asked if the association had a budget for the development of an outdoor range. Mr Buchanan gave details of the 50/50 funding available from a Scottish Sports Council Lottery Grant. Mr Wilkie again pointed out that some form of fundraising and / or sponsorship would have to be undertaken to raise capital for range development. Mr Buchanan agreed and added that the West Edinburgh pistol Club had already contributed £8,000 to development of the site. If the association were to establish a partnership with the WEPC we would be expected to contribute at least the same amount and pay an equal share of the site lease.

Mr Hind asked what the WEPC were intending on using the range for, Mr Buchanan replied that it would be gallery rifle and black powder. The site has an 18-year lease.

8. Presentation of prizes.

Bill Grant was asked if he would present the prizes, which he agreed to do.

The Annual General Meeting closed at 8.15pm with a vote of thanks to the chair.
